



## **The 2022 Sarah Lloyd Scholarship Fund Terms and Conditions**

The Promoter of "The 2022 Sarah Lloyd Scholarship" (the Scholarship) and Sponsor is Sarah Lloyd Scholarship Fund Incorporated (Registration number INC180026) located 4178 Holbrook road, Mangoplah, NSW, 2652.

By applying to the "Sarah Lloyd Scholarship Fund" (the Scholarship), the applicant, or her legal guardian, agrees and accepts the following terms and conditions.

### **1. Eligibility Requirements**

"Sarah Lloyd Scholarship Fund" (the Scholarship) is open to all female Australian residents, residing in the state of New South Wales at the time of entry. All applicants must be currently employed as a full-time Apprentice in a Trade that is deemed Non-Traditional for Women, in which less than 25% of people employed in that trade are women.

Applicants must be at least 16 years old.

Sarah Lloyd Scholarship Fund Incorporated employees, past or present, and their immediate family members, are excluded from applying. Members of the Defence Force or Defence Force families are also excluded from applying.

### **2. Application Time Frame**

Applications for The 2022 Sarah Lloyd Scholarship will be received from 9.00am AEST on 1 May 2022 until 5:00pm AEST on 16 June 2022. Applications can be sent electronically or through Australian Post. Any electronic applicants received after 5:00pm AEST on 16 June 2022 will not be eligible for consideration. Australia Post applications must be received by 5.00 pm AEST on Wednesday 15 June 2022. All applicants who submit an application between 9.00am AEST on 1 May 2022 and 5:00pm AEST on 16 June 2022 will receive an email confirming receipt of application.

A representative from of the Sarah Lloyd Scholarship Fund Incorporated will notify the selected beneficiary of the Scholarship through email or a telephone call by 1 July 2022. If the selected beneficiary of the Scholarship does not acknowledge or accept the Scholarship by 10 July 2022, she forfeits the Scholarship, and a new beneficiary will be selected.

The Scholarship will be formally awarded in a presentation on 16 July 2022 at a to be determined location. The selected beneficiary of the Scholarship is required to attend. If the selected beneficiary of the Scholarship is unable to attend, the Promoter and/or Sponsor must be notified two business days in advance of the presentation.

### **3. Application Entries**

In order to successfully apply, applicants must complete all sections of The 2022 Sarah Lloyd Scholarship Application Form.

The Sarah Lloyd Scholarship Fund Incorporated reserve the right to request winners to provide proof of identity, proof of residency, and proof of employment at the time of entry. Proof of identification, residency and employment considered suitable for verification is at the discretion of the Promoter and Sponsor. In the event that the selected beneficiary cannot provide suitable proof, the beneficiary will forfeit the scholarship in whole and no substitute will be offered.

If the applicant is under the age of 18, the consent of a parent or legal guardian to participate in this scholarship is required. By signing the consent on the application form the parent or legal guardian agrees to these terms and conditions for the applicant to participate.

No Purchase is necessary to participate in the scholarship program.

Odds of winning a scholarship are dependent upon the number of scholarship applications received and the quality of the applications.

Scholarships are to be used to purchase tools, courses, training or work clothing and as such will be paid directly to the supplier on behalf of the scholarship winner. If there is a remaining balance the remaining money will be reinvested in the Sarah Lloyd Scholarship Fund Inc. Scholarships are not transferable. No substitutions or exchanges are permitted.

Any entry that is made on behalf of an entrant by a third party will be invalid, unless the entrant requires the assistance of a third party to enter due to a disability.

#### **4. Rights to Use Likeness; Publicity Release**

Except where prohibited by law, submitting The Sarah Lloyd Scholarship Application Form constitutes permission to use the selected beneficiary's name, trade, and/or Prize information, for promotional purposes without further permission or compensation.
